Section I: Requirements

- 1. Completed application and fee shall be submitted to the Township Secretary forty-five (45) days prior to the "Gathering".
- 2. Any additional information required shall be delivered to the Township Secretary thirty (30) days prior to the "Gathering".
- 3. Inspection and consideration of the request, upon receipt of all necessary or requested documentation and signed application/fee shall be considered by the committee comprised of:
 - a. Chief of Police
 - b. Township Zoning Officer
 - c. Chairman of the Board of Supervisors
 - d. Any other person deemed necessary by the Township Board of Supervisors
- 4. Submit with the application a copy of the insurance certificate providing public liability insurance in the amount of no less than \$300,000.00 for one (1) person and \$500,000.00 for any one accident which shall be in force during the public gathering as defined in Ordinance No. 137 and amended by Ordinance No. 137A.
- 5. The Applicant shall post with the Township Treasurer a cash bond in the sum of \$2,000.00 for faithful observance of the provisions of this ordinance as provided in Section 7 of Ordinance No. 137A.
- 6. The Applicant shall pay at the time of application a permit fee of \$200.00 per day for each day the public gathering is to be convened. A permit issued is valid only for the days indicated on said permit.
- 7. All parking of vehicles shall be on private property, not on state or local right-of-ways. Detail must be provided to show the number and location of the parking spaces. If parking will not be contained solely on the applicant's property, signatures from other property owners must be submitted with application giving permission for use of their property for parking during this event.
- 8. No illegal sale or consumption of alcoholic beverages or drugs shall be permitted (Ordinance #143 and amendments, Section 628).
