- Smoke and Carbon Monoxide detectors on each floor and in good working order
- GFI outlets located per Pennsylvania Uniform Construction Code requirements
- Aluminum or metal exhaust from dryer (if present)
- Fire extinguisher in kitchen, conspicuously located
- Stairs and handrails (indoor and outdoor) in good condition
- Swimming pools, hot tubs, and spas must meet the barrier requirements and indicated in the Pennsylvania Uniform Construction Code
- Evidence of weekly refuse service

All parking must be off of the road right of way

911 address must be posted visible to the street

Golf carts are not permitted on public roads in Sadsbury Township or anywhere in the Commonwealth of Pennsylvania per PA Vehicle Code Title 75. Only Neighborhood Electric Vehicles licensed through the Pennsylvania Department of Transportation are permitted on public roads with speed limits not exceeding 25 mph.
